Moot Yang Gunya Festival Trade Site – Terms and Conditions

Trade site area hire fees are for 3 metres deep X 3 metres frontage. If you require additional space you may purchase extra sites in multiples of 3 metres.

Any trader wanting to sell consumable goods must have and provide a copy of a Current Product Liability Insurance Certificate.

All trade sites are to be set up by 9.30 am on 02/03/13, and dismantled no sooner than 5 pm on 01/03/14.

No vehicles are to be parked on the showground exhibition area after 9.30 am on 01/03/14.

Trade exhibitors are able to hire trestle tables at a cost of \$10. However, exhibitors are welcome to provide their own.

All power cords must be tested and tagged prior to arriving at the show

Extension cords are to be a maximum length of 50 metres.

No raffles, lotteries, sale of bingo tickets, etc. is allowed unless prior permission is obtained from the Show Society.

Show bags and second hand goods will not be accepted by the Society without prior permission. No tents, booths or hawkers will be allowed on the grounds without permission of the Society and any person on the grounds illegally will be liable for prosecution.

The sale of flick, sheath and/or pocket knives, explosives or stink bombs is forbidden.

No private generators are to be used without special arrangement, nor is any private amplification system permitted.

Any person intending to stay on the grounds overnight must pay a camping fee to the Show Society.

Any refunds on trade sites is at the discretion of the Show Society Committee.

Contravention of any of the conditions may mean removal from the showgrounds.

The Show Society reserves the right to restrict the number of any trade sites.
