RULES, BYLAWS & REGULATIONS

1. The management of the Society shall be under the control of an Executive and a Management Team all of whom shall be elected annually at the Annual General Meeting of members. Five shall form a quorum of the Management Team. An auditor shall be elected annually.
2. All persons who subscribe equal to the annual membership or upwards to the last annual Show, shall be entitled to take part in all general meetings of the society and shall be eligible to take office. Any persons not having been members at the last annual Show and wishing to qualify themselves as members at the annual meeting and to be eligible to take office may do so by handing in their names to the administration officer on or before the date of the annual meeting held no later than May 31st each year. The membership fee to be fixed at the annual general meeting.
3. Annual single membership – aged 16 and over (\$15) shall be entitled to one member's ticket to admit to the grounds. All school children aged under 16 will be charged \$5 each. Pre School children – free. Non -members gate price - \$15; pensioners - \$10.
4. All indoor exhibits must be in the hands of the stewards by 9am, (Art and Photography – 8.30am) on the day of the Show. Admission to the Hall at 1pm. Exhibits must not be removed before 5pm. The Society is not responsible for exhibits remaining in the Hall after 6pm. All other exhibits must be on grounds at times indicated in each Section, in time for judging.
5. Judges have the power to withhold any prize if they consider the article not of sufficient merit, or they may award a second prize in lieu of a first.
6. All articles must be bona fide property of the exhibitor.
7. All Grains, Fruit and Flowers to be named as near as possible. Exhibitors may put their name and selling price on their articles after the judges have made their awards.
8. The Management Team will give every possible facility to the exhibitor, and ample accommodation will be provided for exhibits.
9. Every care will be taken of exhibits, but the Society will not under any circumstances hold itself responsible for any loss, mis-delivery, or damage of any exhibit at the Society's Exhibition.
10. The Judge or Management Team have the power to demand a declaration from any person, or persons or grower, should they desire, respecting any exhibit at the Show as to the bona fides of the exhibit.
11. Any person interfering with the judges, stewards or officials of the Society during the Show will be subject to removal from the grounds, and the prizes, if any awarded to them, shall be forfeited.
12. Any exhibitor or attendant refusing to attach the prize card or ribbon to any exhibit to which a prize is awarded and to keep same on during the hours of the Show, will, upon proof thereof to the Judge or Management Team, be disqualified from receiving all prizes awarded to the said exhibitor during the Show.
13. Protests against the decision of the Judges must be made in writing to the Section Convenor before 4pm on the day of the Show.
Protests in Horses-in-Action Section to be made within 15 minutes of completion of event. Such complaints to be accompanied by a fee of \$50, which will be forfeited if the protest is deemed frivolous.
14. All prize money not claimed within one calendar month from the date of the Show may be forfeited to the society. The accounts of the Show will be considered closed as at 30th April afterwards.
15. Changes to the Constitution: in order to alter or change any articles of this Constitution, proposed changes must be in the hands of the Executive two months before either an Annual General Meeting or a Special General Meeting and must be advertised in local media one month prior to the proposed meeting.
16. Non-profit clause: the assets and income of the Society shall be applied solely in furtherance of its principal purpose and no portion shall be distributed directly or indirectly to the members of the Society except as bona fide compensation for services rendered or expenses incurred on behalf of the Society.
17. Dissolution Clause: A motion to dissolve the Society can only be made at an Annual General Meeting or Special General Meeting called for that purpose, having given one month's notice. A motion of dissolution may be put to those present at such a meeting and must be passed by not less than three quarters of the Society's Financial Members. In the event of the Society being dissolved, the amount that remains in Society funds after such dissolution and the satisfaction of all debts and liabilities shall be transferred to another organisation with similar purposes which is not carried on for the profit or gain of its individual members.
