Terms and Conditions

Any trader wanting to sell consumable goods must have and provide a copy of a Current Product Liability Insurance Certificate (Certificate of Currency from your insurance document).

All food vendors must comply with current Food Act and provide Food Business Notification Number.

All trade sites are to be set up by 9.00 am on 01/03/25 and dismantled no sooner than 5 pm on 01/03/25. Please note that we have events that carry over until Sunday, vendors are welcome to stay and trade on Sunday at no extra cost.

No vehicles are to be parked on the showground exhibition area after 9.00 am on 01/03/25.

Vendors can hire trestle tables at a cost of \$10, however we only have a limited number available.

All power cords must be tested and tagged prior to arriving at the show Extension cords are to be a maximum length of 50 metres.

No raffles, lotteries, sale of bingo tickets, etc. is allowed unless prior permission is obtained from the Show Society.

Show bags and second-hand goods will not be accepted by the Society without prior permission.

No tents, booths or hawkers will be allowed on the grounds without permission of the Society and any person on the grounds illegally will be liable for prosecution.

The sale of flick, sheath and/or pocketknives, explosives or stink bombs is forbidden.

Vendors and exhibitors must immediately inform the Show Office staff, and complete an incident report any accidents or injuries occurring at their trade site or as a result of their actions.

No private generators are to be used without special arrangement, nor is any private amplification system permitted.

Any person intending to stay on the grounds overnight must pay a camping fee to the Show Society.

Any refunds on trade sites is at the discretion of the Show Society Committee. Contravention of any of the conditions may mean removal from the showgrounds.

The Show Society reserves the right to restrict the number of any trade sites.
